**Prospective bidders must possess the under-listed requirements to be eligible to participate in this procurement exercise: –**

- (a) Certificate of Incorporation/Registration with Corporate Affairs Commission (CAC)
- (b) Current Tax Clearance Certificates for the last three (3) years (2013, 2014 & 2015)
- (c) Evidence of Current Pension Clearance Certificate in compliance with the Amended PenCom Reform Act 2014.
- (d) Company's Audited Accounts for the last three (3) years (2013, 2014 & 2015 respectively), showing annual turnover
- (e) Evidence of current ITF Certificate in compliance with Industrial Training Fund (ITF) Amended Act, 2011.
- (f) Evidence of Registration on the National Database of Contractors, Consultants and Service Providers by inclusion of Interim Registration Report (IRR) issued by the Bureau of Public Procurement (BPP)
- (g) Evidence of registration with the Nigeria Social Insurance Trust Fund (NSITF) (Certificate only)
- (h) Current sworn affidavit disclosing: –
  - (I) That the company is not in receivership, insolvent or bankrupt.
  - (II) That the company does not have any Director who has ever been convicted in any court in Nigeria or any other country for criminal offence in relation to fraud or financial impropriety
  - (III) Whether or not any officer of the Bureau of Public Procurement (BPP) or officer or Council Member of National Health Insurance Scheme (NHIS) is a former or present Director, Shareholder or has any pecuniary interest in the bidder.
  - (IV) That all documents submitted for the bidding are true and correct in all particulars.
- (i) Company must have current Corporate Membership Certificate with Computer Professionals Registration Council of Nigeria for Lot 15.
- (j) Company must have current Registration with National Insurance Commission (NAICOM) for Lots 9&10

- (k) Evidence of Financial Capability and Banking Support (Bank Reference from a reputable bank)
- (l) Verifiable evidence of similar jobs successfully executed or being executed by the firm (indicating contact addresses of clients, Letters of Award and Completion Certificates)
- (m) Company Profile and Technical qualifications of key professional staff with evidence of current registration with the relevant professional Bodies

### **(3) COLLECTION AND SUBMISSION OF BID DOCUMENTS**

#### **Tender Fees:**

A non-refundable tender fee for the project is Ten Thousand Naira (N10,000.00) only payable by all bidders. **The tender fee should be in Bank Draft payable to National Health Insurance Scheme (NHIS).**

Prospective bidders for the Consultancy Services (Lots 1-13) shall enclose three (3) Technical Documents (one (1) original and two (2) copies) in one envelop marked "Expression of Interest" with the Project Title and Lot Number boldly written at the Top Right Corner of the Envelop.

Prospective bidders for the Works and Supply of Goods Projects (Lots 14-24) shall enclose as follows:

- (a) Two (2) Technical Documents in a separate envelope (marked Technical)
- (b) Two (2) Financial Bid in another envelope (marked Financial)
- (c) Both Technical and financial documents shall be enclosed in one sealed envelope with Project Name and Lot Number.

The submitted bids will be opened on the same day, **29<sup>th</sup> November, 2016 at 12 noon at 3Js Hotel, Opposite Customary Court of Appeal, Utako-Abuja.** Bidders/company representatives and interested members of the public including relevant professional bodies, Civil Society and Non-Governmental Organizations are hereby invited to witness the public opening of the technical bids.

### **PLEASE NOTE THAT**

(d) All CAC, PENCOM, ITF, TAX, BPP, FRC Certificates and/or letters may be referred to the Security Agencies, Corporate Affairs Commission (CAC), Federal Inland Revenue Services (FIRS), National Pension Commission, Bureau of Public Procurement (BPP) and other relevant bodies for verification.

(e) All documents listed above must be arranged in the order of listing in both the original and duplicate copies

(f) Only pre-qualified bidders will be invited for the next stage of the procurement process.

(g) Original documents of any aspect of a company's submission may be requested for sighting.

(h) Bidders are not permitted to bid for more than two (2) lots. **Any bidder that violates this rule shall be disqualified.**

(i) Bidders for lot 15 should have an average annual turnover of not less than N150 million and for lots 7,15 & 18 should have an average annual turnover of not less than N50 million in the last three years (2013, 2014 & 2015) as indicated on the Current Tax Clearance Certificate (TCC).
