- (b) Certificate of registration/upgrade to the right category and annual renewal for the year 2016 with Ambrose Alli University, Ekpoma in:
 - (i) LOT 1, 2, 3, 4, 5, 6, 7 & 9 Category D
 - (ii) LOT 8 Category C
- (c) Current Tax Clearance Certificate for the immediate past three years: 2013, 2014 & 2015.
- (d) PENCOM Certificate of registration
- (e) ITF Certificate of registration,
- (f) Registration with the Bureau of Public Procurement BPP.
- (g) Submission of sworn Affidavit containing a declaration that

(i) The bidder does not have any director who has been convicted in any country for any criminal offence relating to fraud or financial impropriety or criminal misrepresentation or fabrication of facts relating to any matter,

(ii) Whether or not any officer of the relevant committee of the University or Bureau of Public Procurement (BPP) is a former or present Director, shareholder or has any pecuniary interest in the bidder and confirm that all information presented in its bid are true and correct in all particulars.

(A) Financial capability and support letter from a reputable bank

(B) Company's Audited Account for the immediate past three years,

(C) Detailed company profile, with evidence of key staff,

(D) Verifiable similar jobs or supplies executed by the Company in the last three years preferably with Government organizations or corporate bodies; with letters of award, completion certificates and photographs of the projects.

(E) Verifiable list of equipment/machinery with years of manufacture and location to be used for the project.

4.0 PRE-QUALIFICATION FEE:

Bidders are required to pay a non-refundable fee of N30,000.00 per LOT in bank draft, payable to Ambrose Alli University, Ekpoma: and submit same to the Bursary Department and obtain official receipt in same value.
