- (viii) Letter of award and job completion certificate of verifiable previous experience in at least three similar job (s) in the last five (5) years
- (ix) Verifiable evidence of construction of equipment with proofs of ownership or lease agreement.
- (x) Verifiable current certificate of registration with financial reporting council of Nigeria
- (xi) Verifiable evidence of payment for a non-refundable tender fee of twenty thousand Naira
