(1) INTRODUCTION

The Nigerian Agip Oil Company Limited (NAOC) intends to hire 2000HP 10KSI Well Control Equipment for the drilling and completion HP/HT on

NAOC Swamp Well anticipated starting date from June 2019 for one year firm period plus one year optional extension.

NAOC therefore uses this medium to inform suitable and reputable Companies having requisite experience, Rig available in Nigeria and resources for the execution of the project of this magnitude to register or update their registration with NipeX for consideration in the subject opportunity.

(2) SCOPE OF WORK/SERVICE REQUIREMENT

The scope of work will comprise of Development, Appraisal and Exploratory Wells in the drilling, Completion, Workover Suspension Plug and Abandonment and Testing of Wells in the NAOC concession area in the swamp area of operation in water depth of approximately 4.2m water depth on a 24hours/7days basis.

The scope includes;

- Mobilization from point of Origin to first Well site.
- Demobilization of Rig from last operational location.

The requested rig should be fully capable of working in Nigeria Swamp Operational condition, with minimum negative impact on the environment and strict compliance to Health and Safety of all concerned in the activities.

The rig shall have a minimum mandatory requirement of the listed basic capability/equipment to qualify for consideration;

- Rig shall be mobilized tentatively in Q3-2019
- Rig Hoisting capacity: 500Ton of minimum
- Drilling depth capacity with 5" DP/5 ½" DP of 6000m
- Draft of 2.5m with full load for drilling a well.
- Draw works of 2000HP
- Rotary Table opening of 37 ½" x 500Ton
- Top Drive System of 500Ton/WP 7500psi/60,000lb.ft output power built as per ISO 13535 (API 8C-)

- Power capacity of 6000HP
- 3 x 1600HP Mud pumps
- Mud storage capacity of 400m³ with ability for zero discharge facility in line with Nigerian and International laws.
- Cementing lines and Manifold rated 10,000psi Working Pressure
- Well Control Equipment;
- 30" x 500psi Diverter System
- 21 ¼" -3,000psi BOP stack and accessories
- 13 5/8" x 10,000psi BOP stack and accessories

Bidders are invited to express complete understanding, willingness and commitment to comply with the Nigerian Oil and Gas Industry Content Development (NOGICD) Act, 2010 and Insurance ACT 2003. Consequently, bidders' submissions shall be evaluated strictly with the minimum evaluation criteria defined in the NOGICD Act.

The documentation for evaluation shall include but not be limited to the following:

(1) Demonstrate that the entity is a Nigerian indigenous company, Provide details of its Ownership Structure. Submit certified true copies of CAC form (C02 and C07) including Memorandum and Article of Association. Including evidence of being registered on the NCDMB NOGICJQS.

(2) Provide description of in-country committed infrastructure (asset, equipment, technical office, and administrative space, storage, workshop, assembly area, repair, and laboratory, testing, etc.) in Nigeria (offices, equipment etc.) to support this contract.

- (3) Demonstrate in-country sourcing of the base raw materials and chemicals
- (4) Demonstrate in accordance with the NOGICD Act 2010, a minimum of 90% in-country spend as specified in the Schedule A for this service, NCEC approval for this product and service category.
- (5) Provide description of Project-specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel in key areas, in line with NCD Human Capacity Development Initiative
