**Responsibilities/Specifications**

The Contractor (to be engaged) is expected to supply 19 Footer Executive Speed Boats fitted with both rigid and flexible canopies that can be used in all weather.

The Contractor to be engaged will be required to supply one (1) Boat for test- running in the first instance after which subject to satisfactory performance, additional three (3) boats may be purchased subject to approval of the Executive Secretary. In addition, the boat must have proof of guarantee durability and also meet the following specifications;
