- (iv) Evidence of current Pension Clearance Certificate from PENCOM Evidence of Compliance Certificate with the provisions of section 6(1) (3) of the amended Industrial Training fund (ITF) Act No 19 of 2011
- (v) Evidence of similar and verifiable projects executed (not just awarded) within the last three (3) years and knowledge of the industry.
- (vii) Company Annual Turnover
- (viii) Evidence of VAT Registration Certificate and Remittances including TAX Identification Number.

- (ix) Evidence of Key Staff Registration Certificate with Relevant Professional Bodies
- (x) Comprehensive Company Profile and Organizational Structure
- (xi) Evidence of availability of necessary Equipment/Personnel
- (xii) Evidence of Technical capacity
- (xiii) Letter of Comfort from Bank
