# **Appointment of External Auditors**

## **Background**

The Petroleum Training Institute (PTI), a Parastatal of the Ministry of Petroleum Resources was set up by Act No. 37 of 1975 and subsequently amended by Act No. 52 of 1975 to train middle level manpower for the Oil, Gas and Allied Companies. # **Scope of Services Required**

# **Pre-Qualification Requirements**

- ii. Evidence of registration with the office of Auditor General of the Federation in the year the appointment is being set,
- iii. Firm's profile, such as experience, technical qualification of key staff not less than ten (10) in numbers. Evidence of financial capability/Bank Reference,
- iv. Audited Accounts for the last three (3) years,
- v, Evidence of valid Tax Clearance Certificate for the last three (3) years,
- vi. Evidence of VAT registration certificate
- vii. Evidence of firm's existence with not less than ten (10) years of satisfactory performance, and

viii. Evidence of registration with PENCOM for the firm's employees,

#### **Tenure**

The appointment shall be for one (1) year in the first instance and renewable subject to satisfactory performance for a maximum of two (2) years

#### **Fees**

Fees will be negotiated on man-hour basis as obtainable from at least three (3) accredited firms of Chartered Accountants from the list at the office of the Auditor General of the Federation. This will be negotiated and determined as part of the final selection process.
