Chevron Nigeria limited invites interested and prequalified companies for this tender opportunity for the provision of Corrosion Prevention and Control Services in its swamp locations, offshore fields and any other locations as required to support: CNL's ongoing oil and gas production activities. The proposed contract term is 3 (Three) years with an option of 1 (one) year extension.

#### SCOPE OF WORK:

## The scope of work for the services includes but not limited to the following;

(A) Provision of all materials, tools and spare kits, equipment necessary to support design, fabrication, installation, inspection, monitoring, testing and maintenance of Company's Corrosion Protection and Control systems.

(B) Performance of Direct Current Voltage Gradient according to international standards (NACE Standard SP0207-2007) and Company's specifications or any other survey to determine coating condition on Company's specified Pipelines.

(C) Performance of Close Interval Potential Survey according to NACE Standard SP0207-2007 and Company Specifications to determine corrosion status on Company specified Pipelines.

(D) Performance of Direct Assessment on company specified pipelines according to NACE Standard SP0502-2010.

(E) Performance of pipeline integrity surveys such as topography survey, depth profile on company specified pipelines

(F) Performance of MTM (Magnetic Tomography) on company specified pipelines.

(G) Performance of tests such as resistivity measurements, soil test, and water analyses, etc., to support corrosion protection, prevention and control activities,

(H) Provision of qualified and certified personnel such as NACE, API, NDE/NDT, etc. to carry out services covered in the scope of work.

Nigerian content requirements:

(C) Provide evidence of the percentage of (1) key management positions that are held by Nigerians and (2) total work force that are Nigerians. Also, show overall percentage of work to be performed by Nigerian resources relative to total work volume,

(D) Provide a Nigerian Content Plan with a detailed description of the role, work scope, man-hours and responsibilities of all Nigerian companies and personnel that will be involved in executing the work. Also provide details of Nigerian Content contact or manager.

(E) State proposed total scope of work to be performed by Nigerian personnel (whether contracted directly or under subcontract agreements) with names and addresses including evidences of well-equipped offices and workshop; attach past experience of such patronage.

(F) Specific to this project, provide detailed plan for staff training and development on engineering, project management and procurement (including all software to be used, number of personnel, name of organization providing such training and evidence of past training record) for Nigerian personnel including description of any specific programs in place for transfer of technology and skills to indigenous businesses and Nigerians over the new five (5) years.

(G) Provide evidence of domiciliation of prefect management and procurement centers in Nigeria with physical addresses (not P.O. Box).

(H) Location of in-country facilities, (Equipment, storage, workshops, repair and maintenance facilities and, testing facilities),

(I) Contractor must be willing and able to provide evidence of maximization of made in Nigeria goods and services,

(J) Provide details on any other Nigerian Content initiative your company is involved in.

(K) Provide evidence of MOU with OGTAN registered trainer to conduct classroom module of training and on the job attachment

(L) Provide human capacity building development plan including budget which must be minimum 10% of project man-hours or cost Training will be targeted at developing capacity other than bidder's personnel. Trainees will be nominated from a database maintained by NCDMB and the services of OGTAN registered trainers utilized to cover classroom modules,

(M) Provide details of equipment ownership,

(N) Bidders (Vendors, Original Equipment Manufacturers-OEMs, and EPC Contractors) are required to present Nigerian Content Equipment Certificate (NCEC) issued: by Nigerian Content Development and Monitoring Board (or evidence of application for the certificate) in respect of any components, spares, equipment, systems and packages to be used in the proposed project under tender,

(O) All Bidders for a project/contract/service with a completion period of 12 months or more are required to submit as part of the Nigerian Content requirement, a signed Memorandum of Agreement (MOA) between it: and one of the research and development (R&D) Clusters established by the Nigerian Content Development and Monitoring Board (NCBMB), The MOA shall be relevant to the project and shall indicate how the bidder intends to use the relevant R&D Clusters during project execution.

(P) As contained in Nigerian Content directives only indigenous companies or indigenous companies in genuine alliances are qualified to tender for onshore (Sand or swamp) services.
