- (v) Evidence of Compliance with Financial Reporting Council of Nigeria (RFCN) Act No. 6 (2011).

- (vi) Valid Industrial Training Fund (ITF) Certificate in compliance with iTF Act 2005.
- (vii) Interim Registration Report (IRR) as evidence of registration on National Database of Contractors, Consultants and Services Providers in line with Section 16(7) of the Public Procurement Act (PPA), 2007.
- (viii) Audited company account for the last Three (3) years (2014, 2015 and 2016).
- (ix) Evidence of similar jobs completed/on-going by the company.
- (x) Evidence of financial strength, credit-worthiness and solvency from company's Banker(s).
- (xi) A sworn affidavit in line with the provisions of Part IV, Section 16, Subsection 6(f) of the Public Procurement Act, 2007 stating that:
  - (a) All documents/information presented are genuine and verifiable
  - (b) The Director(s) of the firm has/have never been convicted by any court of law within or outside Nigeria.
  - (c) None of the company's Directors or the company itself is bankrupt
  - (d) None of the officers of University of Benin Teaching Hospital (UBTH) or Bureau of Public Procurement (BPP) is a former or present staff of the company.
  - (e) The firm is not in receivership.

These documents are to be arranged in the order in which they are listed.

#### **4.0 COLLECTION OF BIDDING DOCUMENTS**

Interested companies are to collect the Tender Documents from the Procurement Division (Room 12), Administrative Block, (Laundry Extension; from the date of publication of this advert, between the Hours of 9.00am and 4.00pm daily, with evidence of payment of a non-refundable fee of N10,000.00 (Ten Thousand naira) only per lot to be paid through REMITA PLATFORM to JBTH at any Commercial Bank and a copy of the receipt presented before the collection of Tender documents.

Tender documents are to be enclosed in two separate envelopes, one to contain the Technical Bid and boldly marked "TECHNICAL BID" on the top right corner and the other to contain the Financial bid and boldly marked "FINANCIAL BID" on the top right corner. All Tender documents are to be submitted not later than **12.00 noon on Thursday 7<sup>th</sup> December, 2017**. Bids submitted after the deadline for submission shall be rejected.

All submissions are to be made in English Language.
