

CORRIGENDUM TO INVITATION TO TENDER FEDERAL COLLEGE OF EDUCATION, YOLA

All interested bidders are advised to take note of the following amendments to the earlier publication:

“Evidence of Registration as an Engineering/Equipment Contractors with the Federal Ministry of Works” and “Evidence of Vat Registration with TIN and past Remittances for the last three years from the advertisement has been expunged and replaced with the following criteria:

- (i) Evidence of current Tax Clearance Certificate for the past three (3) years (2014, 2015 and 2016);
- (ii) Evidence of current Pension Compliance Certificate (2017)
- (iii) Evidence of Current Industrial Training Fund (ITF) Compliance Certificate (2017);
- (iv) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate (2017);
- (v) Verifiable documentary evidence of at least three (3) similar jobs including Letter of Awards, Valuation Certificates and job Completion Certificates in the last five (5) years;
- (vi) Sworn Affidavit disclosing whether or not any officer of the relevant committee of the Federal College of Education, Yola, or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in the bid are true and correct in all particulars;
- (vii) Audited Accounts for the last three (3) years (2014, 2015 and 2016)
- (vii) Evidence of registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring 1/1/2018 or valid Certificate issued by BPP;
