(A) The State of Osun Universal Basic Education Board on behalf of Universal Basic education Commission (UBEC) Abuja and in compliance with Due Process requirements on award of contracts hereby invites all interested companies and allied Corporate Agencies to forward their documents for pre-qualification and subsequent bidding (By qualified contractors only) for the **Construction of Blocks of Classrooms, Procurements of Furniture and ICT Materials.**

- (ii) Construction of 1000 capacity model (JSS) middle school building with Laboratory/Library , Headmaster's offices and staff common room equipped with plumbing ;and Electrical works inclusive (Lot 1)
