Also to be procured and distributed are Library Resource/Reference Materials and other Instructional Materials for the nation's basic education school system using the Instructional Materials Fund

Towards this end, UBEC hereby invites eligible Publishers/Suppliers whose core Textbooks are used in Public Primary and Junior Secondary schools in any of the 36 States and FCT as compiled from the various Universal Basic Education Boards to collect and submit pre-qualification documents as follows:

**S/N: B**

Textbooks, Library Resource Materials and other Instructional Materials: Production/Supply of Library Resource/Reference Materials for ECCDE, Primary and Junior Secondary Schools (JSS) in accordance with Titles/Publishers Identified by the State Universal Basic Education Boards (SUBEBs)

**S/N: C**

Textbooks, Library Resource Materials and other Instructional Materials: Production/Supply of other essential Instructional Materials such as Science and Laboratory Equipment  
Such eligible Publishers/Suppliers are expected to submit pre-qualification documents for the production and supply of core Textbooks, Library Resource/Reference Materials and other Instructional Materials for ECCDE, Primary and Junior Secondary Schools (JSS) in accordance with the Titles/Publishers identified by the Universal Basic Education Boards.

Note: Any Publisher whose book is not recommended for use in public Primary and JSS schools in any of the 36 States and FCT need not collect pre-qualification documents

**PRE-QUALIFICATION REQUIREMENTS**

**The following supporting documents which are considered key eligibility requirements should be provided.**

1. Evidence of Registration/Incorporation with Corporate Affairs Commission (CAC) Certificate
2. Photocopies of Tax Clearance Certificates for the last three (3) years (2013, 2014 and 2015)
3. Evidence of Current PENCOM, ITF and NSITF Compliance Certificates
4. Evidence of Interim Registration Report (IRR) issued by BPP
5. Company profile including Address of Office, Factory or Printing Press
6. Evidence of financial capability from a reputable bank acceptable to UBEC including Bank Reference stating credit worthiness and Bank Statements depicting monetary transactions of the bidder & capability to execute the projects
7. Evidence of previous similar jobs successfully executed with Award and Completion Certificate verifiable by UBEC in the production and supply of Textbooks, Library Resource Materials & other essential Instructional Materials to State Universal Basic Education Boards or public schools

8. A sworn Affidavit of disclosure of interest that none of its Directors is a serving or retired member of UBEC and that none of the Directors of the firm has been convicted of any criminal offence relating to fraud, financial impropriety, falsification or acts similar in nature. Affidavit submitted must be deposited as described

9. A letter of Authority/M.O.U. for the use, supply or sale of intellectual property

10. All documents must be properly bound and numbered with a well arranged Table of Contents.
