The attention of the public is hereby drawn to some amendments/additions to the above mentioned publications. Prospective experienced and competent contractors/suppliers are to note the following replacements of eligibility criteria ii, iv, v, vi. vii, ix, x. xi and addition of a new criteria for procurement of operational vehicle with the following descriptions:

- (i) Detailed company profile with curriculum vitae of key staff and copies of their professional qualifications:
- (ii) Evidence of current Pension Compliance Certificate valid till 31st December. 2018.
- (iii) Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31st December, 2018:
- (iv) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31stDecember, 2018;
- (v) Verifiable documentary evidence of at least three (3) similar jobs in the last five (5) years including Letter of Awards, Valuation Certificates and Job Completion Certifications;
- (vi) Evidence of Sworn Affidavit disclosing whether or not any of officer of the relevant committees of the University of Benin Teaching Hospital or the Bureau of Public Procurement is a former or present Director, Shareholder or has any pecuniary Interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars:
- (vii) Evidence of financial capability to execute the project by submission of reference letter from a reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed;
- (viii) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 1/1/2019 or valid Certificate issued by BPP;

(ix) Only local manufacturers/assemblers of vehicles approved by the National Automotive Design and Development Council or their authorized dealers are eligible to bid for lot 2 (Supply of 1 No. Operational Vehicle).
