INTRODUCTION

Enugu Medical Diagnostic Center is situated in the heart of Enugu metropolis with good road access, sitting on over 1.5 hectares of land including a total of 6,700 square meters of built up space on four (4) floors.

It is equipped with state-of-the-art Medical Imaging Equipment and will have adequate arrangement for grid power as well as water supply and discharge.

EMDC is the largest of its kind in the Southeast Nigeria and is therefore uniquely positioned to accelerate commercial activities in Enugu and across the Southeast geopolitical region.

To date, EMDC has been financed solely by Enugu State Government and is designed to accommodate major international and domestic institutions for management.

Enugu is the former capital of the defunct Eastern Nigeria with a working class population estimated to be more than a million people with good purchasing power.

The surrounding cities of Awka, Owerri, Abakaliki will also form the initial catchment area of medical tourists to the center.
