- (e) Evidence of current Nigeria Social Insurance Trust Fund (NSITF), valid till 31 December 2018
- (f) Evidence of Registration on the National Database of Federal Contractors, Consultant and service providers by submission of Interim Registration Report (IRR) or valid Certificate issued by BPP
- (g) Evidence of Firm's registration with relevant professional body e.g. COREN/QSRBN/ARCON/CORBON/SURCON/Construction.
- (h) Letter of Authority in favour of University of Port Harcourt to verify any claim(s) contained in the respondent's submission
- (i) Specific Condition:
- (a) All submission must be prepared in English language
- (b) Firms wishing to be prequalified as a Consortium must be registered with CAC and with relevant professional regulatory bodies. In such cases, the requirements stated above must be in the name of the Consortium.

- (b) The claims made in the submission are true and correct in all ramifications.

- (d) No Director or Principal of the Firm (past or present) has ever been convicted on criminal charges in any court of law in Nigeria.
