**(1.0) PREAMBLE**

The Tertiary Education Trust Fund has allocated funds to FCT College of Education, Zuba for the year 2016/2017/2018 (Merged) Tetfund Intervention in ICT Support. The Institution hereby invites reputable ICDL certified and qualified firms with good track record of performance to submit bids for the execution of the underlisted projects.

**(2.0) SCOPE OF WORK**

The projects for execution are as follows:

<b>Lots</b>	<b>Lot Description</b>
A	Website upgrade, Design, Migration, Hosting for one year, commissioning and ICT Staff training.
B	ICDL computer training (Base and Intermediate)

**(3.0) ELIGIBILITY CRITERIA**

The College in compliance with the PPA 2007 and the Bureau of Public Procurement (BPP) guidelines will carry out pre-qualification of companies that responded to the advert based on the following requirements:

- (i) Evidence of registration with Corporate Affairs Commission.
- (ii) Certified true copy of Memorandum and Article of Association
- (iii) Evidence of payment of Tax for the last three years i.e. 2016, 2017 and 2018.
- (iv) Current certificate of compliance issued by the National Pension Commission PENCON.
- (v) Evidence of current Industrial Training Fund compliance certificate.

- (vi) Evidence of VAT Registration and payment.
- (vii) Evidence of current Certificate or compliance with National Social Insurance Trust Fund (NSITF).
- (viii) Evidence of registration as ICDL Accredited Test Centre and Certified ICDL Trainer.
- (ix) Evidence of registration with computer professional of Nigeria (CPN).
- (x) Evidence of registration with National Information Technology Development Agency (NITDA).
- (xi) Company's audited account for the last three years i.e.'2016,2017 and 2018.
- (xii) Evidence of Registration on the National Database of contractors by inclusion of Current interim registration receipt issued by the Bureau of Public Procurement (BPP).
- (xiii) Bank reference indicating financial capability of the contractor. Company profile with the CVs of staff which should include both Academic and Professional qualifications.
- (xiv) Verifiable and documentary evidence of at least three (3) similar jobs executed to include award letters and certificate of completion

NB: Any other relevant documents that can facilitate prequalification will be an added advantage.

#### **(4.0) SUBMISSION OF EOI DOCUMENTS**

Prospective firms are to submit bid for each lot desired separately packaged in sealed envelopes and clearly marked EOI and addressed to the Provost FCT College of Education, Zuba, Lokoja – Kaduna Expressway. The submission should clearly indicate the name of the project and the lot number. The reverse side of each sealed envelope should bear the name and address of the Bidder. The sealed documents should be dropped at the Procurement Unit of the College not later than six weeks from the date of the advertisement (**16, March 2020**).

All EOI documents received will be opened at the expiration of the advertisement period by **12:00pm** at the College Board Room.
