### **ELIGIBILITY**

- (i) Evidence of Certificate of Incorporation with the Corporate Affairs Commission (CAC) including Form CAC2 and CAC7;
- (ii) Evidence of Company Income's Tax Clearance Certificate for the last three (3) years valid till 31st December, 2020;

- (iii) Evidence of current pension Compliance Certificate valid till 31st December, 2020;
- (iv) Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31st December, 2020;
- (v) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) compliance certificate valid till 31st December, 2020;
- (vi) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 01/01/2021 or valid certificate issued by BPP;
- (vii) Evidence of Tax clearance from Ekiti State Government for 3 years;
- (viii) Evidence of payment of development levy for 3 years;
- (ix) Sworn affidavit disclosing whether or not any officer of the relevant Committees of Ekiti State University Teaching Hospital or the Bureau of Public Procurement is a former or present Director Shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;
- (x) Company's Audited Accounts for the last three (3) years – 2017, 2018 and 2019;
- (xi) Evidence of financial capability to execute the project including reference letter from a reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed;
- (xii) Company Profile with the Curriculum Vitae of key staff to be deployed for the project, including copies of their academic/professional qualifications e.g. COREN, QSRBN, ARCON, CORBON etc.;
- (xiii) Verifiable documentary evidence of at least three (3) similar jobs executed in last five (5) years including Letter of Awards, Valuation Certificate, Job Completion Certificates and Photographs of Projects;
- (xiv) List of plants/equipment with proof of ownership/lease;

The letter head paper must bear the Name and Nationalities of the Directors of the Company at the bottom of the paper, duly signed by the authorized officer of the firm.
