- (b) Evidence of Company Registration with Corporate Affairs Commission
- (c) Verifiable list of similar and other jobs successfully executed with their locations (d) verifiable list of plants/machinery with years of manufacture and locations of the equipment to be used in the project. Please state whether the equipments are on lease, hire or owned by the company with evidence of purchase where applicable
- (e) List of key staff with their Curricula Vitae and relevant positions that will execute the project
- (f) company's financial details and audited accounts for the last three years
- (g) Valued Added Tax Certificate (VAT Certificate).
- (h) An affidavit disclosing whether or not any officer of the relevant committees of the Obafemi Awolowa University or the Bureau of Public Procurement is a former or present director, shareholder or has any pecuniary interest in the bidding company.

### **Submission of Pre-qualification Documents**

The relevant pre-qualification documents should be neatly packaged in binders and sent in separate sealed envelopes for each project and clearly marked "**Pre-Qualification to Tender for the Projects on the Year 2010**"

All submissions for pre-qualification in respect of each of the projects/lots shall enclose a bank draft for a sum of forty thousand naira (N40, 000.00) only per project payable to Bursar, Obafemi Awolowo University, Ile-Ife.
