# (A) Background

- (3) Draw on their extensive market knowledge to advise FHI360 cm issues relating to policy benefits, extensions, and available options
- (4) Leverage on their experience and expertise to help FHI360 select insurance policies that deliver risk solutions at the most competitive rates, and execute same with identified insurers) on behalf of FHI360
- (5) Be responsible for administering the policy as may become necessary, to settle claims that may arise
- (6) Ensure prompt and efficient claims administration and processing
- (7) Provide other professional services as may be required from time to time, related to group life assurance

(8) Provide access to information on trends or other insurance related news from around the world

## (C) Selection Criteria

- (2) Evidence of company registration (i.e. Certificate of incorporation Corporate, form CAC7 & CAC2).
- (3) Evidence of payment of tax (tax clearance certificate) for the last three years 4 Evidence of financial capability i Bank reference letter
- (5) ii. Audited financial statements for the last three years (showing minimum average annual turnover of N50million during the three-year period)
- (6) Certificate of registration and valid/current membership with the National Insurance Commission (NICOM)
- (7) Certificate of registration and valid/current membership with the Nigerian Council of Registered Insurance Brokers (NICRIB)
- (8) Evidence of experience in taking out and administering group life assurance policies for reputable organizations (especially INGOs)
- (9) Evidence of successful settlement of at least five claims (of minimum value of N15million each) on life assurance policies within the last three years, with clear indication of how long it took to settle the claim

(10) Recommendation Letter from three reputable and notable past or present clients attesting to satisfactory performance in previous provision group life assurance services
