(3) Note that the bid documents would be evaluated on responsiveness to criteria including but not limited to: Registration with Corporate Affairs Commission (CAC), Company's Audited Accounts for 3 years, Company Income Tax (CIT) for 3 years, Compliance Certificate from Pension Commission (PENCOM), Compliance Certificate from Industrial Training Fund (ITF), Compliance Certificate from Nigeria Social Insurance Trust Fund (NSTIF), Evidence of Financial Capability, Interim Registration Report (IRR) or valid Certificate issued by BPP. Documents submitted may be subjected to due diligence without recourse to bidders.

(4) The Federal College of Education, (Technical) Umuze, Anambra State also reserves the right to invoke the provision of Section 28 of the Public Procurement Act (PPA) 2007 on matters regarding in these procurement without incurring any liability to the bidder.
