

FEDERAL MEDICAL CENTRE, JALINGO INVITATION FOR PRE-QUALIFICATION AND TENDER FOR OUTSOURCE ADDENDUM

GENERAL ELIGIBILITY REQUIREMENT

- (i) Evidence of current tax clearance for the past three (3) years -2015, 2016, 2017 valid till Dec; 31st 2018.
- (ii) Evidence of current pension compliance certificate valid till 31st Dec 2018.
- (iii) Evidence of Industrial Training Fund (ITF) compliance certificate valid till 31st Dec; 2018.
- (iv) Evidence of Registration on the National Data Base of federal contractors, consultants and service providers by submission of Interim Registration Report (IRR) expiring on 30/6/2018 or valid certificate issue by B.P.P.

- (i) Evidence of current Nigerian Social Insurance Trust Fund (NSITF) compliance certificate valid till 31st Dec; 2018.
- (ii) Evidence of sworn affidavit disclosing whether or not any officer of the relevant committee of Federal Medical Centre, Jalingo or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that the information presented in the bid are true and correct.
- (iii) Evidence of financial capability by submission of reference letter from a reputable commercial bank indicating willingness to provide credit facility for the execution of this project when needed.
- (iv) Verifiable documentary evidence of at least three (3) similar jobs in the last five (5) years including letter of award, interim payment certificate/ completion certificate.

(v) Evidence of Registration/Annual renewal with the Nigeria Security and Civil Defence Corps (NSCDC) (for Lot1) and Environmental Health Officers Registration Council of Nigeria (EHORECON) (for Lot 2).
