(1) The Federal Government of Nigeria has received financing from the African Development Bank (hereinafter called the Bank) towards the cost of the Inclusive Basic Service Delivery and Livelihood Empowerment Integrated. Project and intends to apply part of the proceeds toward payments under the contract for the Construction of Hostels and Classroom in Lassa FSTC in Borno State of Nigeria. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the Bank's Disbursement Guidelines and procedures for Investment Project Financing.

(2) The Technical and Science Education Department of the Federal Ministry of Education now invites sealed Bids from eligible Bidders for Construction of Buildings in Lassa Federal Science and Technical College Borno State, comprising; 3Nos. hostels for boys (48 bed capacity), 1 Nos. hostel, for girls (48 bed capacity), 1No Classroom block with an eight (8) month completion period.

(3) Bidding will, be conducted through, the Open Competitive Bidding (International), OCBI procedures as specified in the Bank's Procurement Framework of October 2015

(<https://www.afdb.org/en/projects-and-operations/procurement/new-procurement-policy>), and is open to all eligible Bidders as defined in the Procurement Framework.

(4) Interested eligible Bidders may obtain further information from the address indicated below in paragraph 9 and inspect the bidding document during the indicated hours (9:00am to 4:00pm) during working days at the same address.

(5) The bidding document in English language may be purchased by interested eligible Bidders upon the submission of a written application to the address below with evidence of payment of a nonrefundable fee of Twenty thousand Naira (N20,000.00) only. Payment should be made to Inclusive Basic Services Delivery and Livelihood Empowerment Integrated Programme: Additional. Financing with the Central Bank of Nigeria. The Payment description should be indicated as "Tender Fees". The bidder shall be required to present evidence of payment at the address below for collection of the bid documents. The document can also be sent by email on submission of the proof of payment as indicated above, or by courier services on request with an additional payment of N15,000:00.

(6) Bids must be delivered to the address below an paragraph 9 **on or before 12 noon local time, Tuesday 12 January, 2022**. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below by **12:30pm Tuesday 12 January, 2022**.

(7) All Bids must be accompanied by a Bid Security of Eighteen Million Naira. (N18,000,000.00) only.
