(d) That information presented in its bid are true and correct in all particulars";

(vii) Evidence of Interim Registration Report (IRR) Certificate expiring on 31st December, 2022 or valid Certificate issued by BPP;

(viii) Verifiable documentary evidence of at least three (3) similar jobs in the last five (5) years including Letter of Awards, Valuation Certificates and Job Completion Certificate;

(ix) Company Profile with Curriculum Vitae (C.V) of key staff to be deployed for the project including copies of their academic/professional certificates;

(x) Reference Letter from a reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed.

(xi) Interested bidders must have Minimum annual turnover of N20million.
