I am directed to acknowledge your letter dated 15th June, 2015 on the above subject.

I am further directed to inform you that the above projects were captured under the 2014 appropriation Act as follows:

- Purchase of Motor Vehicles
- Construction/Provision of Office Building
- Construction/Provision of Water Facilities

Within the year, the sum of **₦6,320,978.00** (Six million, three hundred and twenty thousand Naira) only, was released by the Federal Government in the *first quarter*.

In the *second quarter*, the sum of **₦15,612,504.00** (Fifteen million, six hundred and twelve thousand, five hundred and four Naira) only.

Therefore, the total sum released by the Federal Government to the Nursing and Midwifery Council of Nigeria in 2014 was **₦21,933,482.00** (Twenty one million, nine hundred and thirty three thousand, four hundred and eighty two Naira) only.

The above sum was *grossly inadequate* to be utilized for the aforementioned projects and not only that, the funds were released very late towards the end of year 2014.

Considering the fact that all procurement procedures must be adhered to in the execution of the projects, and having in mind the limited time to complete the due process, ***the Council could not execute any of the projects*** and finally ***returned the total sum released to the Council to the Federation Account.***
