I am further directed to inform you that in 2015 fiscal year, **₦20,000,000.00** (**Twenty million, Naira**) only, was appropriated to the Council for capital projects.

At the end of the first quarter, the sum of **₦10,000,000.00** (**Ten million, Naira**) only, was released by the Federal Government to the Council, no any other funds was released until the end of year 2015.

Therefore, the total sum released by the Federal Government to the Nursing and Midwifery Council of Nigeria in 2015 was **₦10,000,000.00** (**Ten million, Naira**) only.

The above sum was ***grossly inadequate*** to be utilized for the any project(s).

Considering the fact that all procurement procedures must be adhered to in the execution of the projects, and having in mind the total sum released to the Council to date, ***the Council decided to stay execution on any project(s)*** and finally, ***the total sum released to the Council was mobbed up at 12 midnight by 31th March, 2016 to the Federation Account.***
