(1.0) INTRODUCTION

The Management of Ebonyi State University Abakaliki hereby issues the general procurement notice to inform eligible Contractors, Suppliers, vendors and the general public that the University is to undertake procurement of works and goods under years 2011, 2012, 2013 and 2014 TETFund Intervention in Library Development.

(2.0) SCOPE OF PROJECTS

Lot 1 Procurement of various Books and journals

Lot 2 Procurement of various Library Equipment for the University Central Library

Lot 3 Procurement of Bindery Equipment and Accessories for EBSU Central Library

(1) Interested and eligible Contractors, Suppliers and Vendors are advised to lookout for the Specific Procurement Notice (SPN) for the various projects and goods mentioned above in the National Dailies and Notice Boards depending on the threshold of each project

(3) The Advertisement is NOT an invitation to tender

(4) Note that the bid documents would be evaluated on responsiveness to criteria including but not limited to:

(i) Certificate of Registration Incorporation with Corporate Affairs Commission (CAC)

(ii) Evidence of current Tax Clearance Certificate valid till 31st December, 2018,

(iii) Evidence of current Pension Compliance Certificate valid till 31st December, 2018;

(iv) Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31st December, 2018;

(v) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31st December, 2018;

(vi) A Sworn Affidavit disclosing;

(a) That the company is not in retainership, Insolvent or Bankrupt

(b) That no Director of the Company has ever been convicted in any court in Nigeria or any other country for criminal offences relating to fraud or financial impropriety

(c) Whether or not any officer of the relevant committees of the Ebonyi State University or the Bureau of Public Procurement is a former or present Director shareholder or has any pecuniary interest in the bidder

(d) That information presented in its bid are true and correct in all particulars;

(vii) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) Certificate issued by BPP valid till 1st January, 2019.

(viii) Verifiable documentary evidence of at least three (3) similar jobs in the last five (5) years including Letter of Awards, Valuation Certificates and Job Completion Certificate

(ix) Company Profile with Curriculum Vitae (CV) of professional staff to be deployed for the project including copies of their professional qualifications

(x) Evidence of financial capability to execute the project by submission of Reference Letter from a reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed

(xi) No bidder should bid for more than two (2) lots

(xii) Interested bidders must have Minimum Average Annual turnover of N20 million.
