- (iv) Evidence of Current Industrial Training Fund (ITF) Compliance Certificate valid till 31st December, 2019.
- (v) Evidence of Current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31st December. 2019.
- (vi) IRR expiring on 91/01/2020
- (vii) A sworn Affidavit disclosing;

- That the company is not in Receivership, Insolvent or Bankrupt.
- That no Director of the company has ever been convicted in any court in Nigeria or any other country for criminal offences relating to fraud or financial impropriety
- Whether or not any officer of the relevant committee of the Federal College of Education, Abeokuta, or the Bureau of the Public Procurement is a former or present Director, Shareholder or has any pecuniary interest in the bidder. That information presented in its bids are true or correct in all particular;

(viii) Verifiable documentary evidence of at least three (9) similar jobs in the last five years including letter of award, valuation certificate and job completion certificates or referrals.

(ix) Companies provide with curriculum vitae (CV/) of professionals to be deployed for the project including copies of their professional qualification.

(x) Evidence of financial capability to execute the projects by submission of reference letter from reputable commercial Bank indicating willingness to provide credit facility for the execution of the project when needed.
