(1.0) BACKGROUND

In line with its transformational Agenda to become Africa's Model Megacity, the Lagos State Government (LASG) is in the process of revamping the infrastructure in her public secondary and tertiary health facilities.

In compliance with the requirements of the Lagos State Public Procurement Law 2011, the Lagos State Ministry of Health (LSMOH) now invites sealed bids from eligible and qualified bidders for the renovation of public secondary/tertiary health facilities as indicated below:

(2.0) This National Competitive Bidding Process as specified by the State Procurement Guidelines for the procurement of Works is open to all bidders from eligible countries as defined in the Guidelines- www.lagosppa.gov.ng

(3.0) QUALIFICATION REQUIREMENTS FROM INTERESTED PARTIES

- Evidence of Registration with Corporate Affairs Commission (CAC) with the inclusion of Certificate of Incorporation and Articles of Association.
- Company profile and organizational structure with the Curriculum Vitae and Professional certificates of key personnel
- Evidence of valid and current registration with the Lagos State Public Procurement Agency with appropriate class.
- Current tax clearance certification of the company and two Directors for the years 2013, 2014 and 2015
- Audited Financial Statements of the company for the years 2013, 2014 and 2015
- Evidence of available financing and/or access to credit line
- Evidence of previous experience and expertise as prime contractor in 2 projects of similar nature and complexity over the last five (5) years. This should include the following details.

- Name of Project, Brief Description and Client(s)
- Scope of work, Contract Value, Nature of Contract (PPP, Lump Sum etc) and Contractual Period
- Name and address of related client's referee
- The cited works should be accompanied with Certificates of Completion or evidence of at least 70 % completion.

(4.0) SUBMISSION OF BIDDING DOCUMENTS

(4.1) A Complete set of bidding documents in English Language may be purchased upon the payment of a non-refundable fee of N20,000 (Twenty Thousand Naira) per lot and N10,000 (Ten Thousand Naira) for each additional lot which should be made to Skye Bank, Alausa Secretariat Branch Account no 08004 4030010449, Revenue Code 33101 and Tellers/ receipts submitted at the Ministry of Health's Procurement Office, Block 4, Room 313 The Secretariat, Alausa-Ikeja

(4.2) One (i) original copy and three (3) other copies of Bids are to be Delivered in a sealed envelope clearly marked "If B- Renovation of Public Secondary and Tertiary Health Facilities" with the lot number clearly indicated on the outer envelope

(4.3) All bids should be accompanied with a bid security of 1% of bid price
