

# **INVITATION FOR EXPRESSION OF INTEREST FOR PURCHASE OF NLNG PLANT ASSETS (SPARE PARTS AND EQUIPMENT) AVAILABLE FOR DISPOSAL NIGERIA LNG LIMITED**

## **INTRODUCTION**

Nigeria LNG Limited (NLNG) has a Plant Complex located in Bonny Island, Rivers State, Nigeria. It consists of six natural gas liquefaction trains with a total capacity of 22 million tons of Liquefied Natural Gas (LNG) and 5 million tonnes of Natural Gas Liquids (NGL) per annum, with associated gas receiving, treating, storage and loading facilities as well as utilities (Electrical Power Generation, Water, Air, Nitrogen etc.) and support infrastructures (offices, residential accommodation, school, hospital, airstrip, jetties etc.)

Following recent upgrade projects, NLNG has set aside some spare parts and equipment for disposal to interested buyers. These spare parts and equipment which NLNG intends to sell “as is” include but are not limited to; Process Compressor Rotors and Parts, Pump Rotors and Parts, Air Conditioner Spares, Valves and Associated Spares, Heat Exchanger, etc. Companies that express their interest by email as specified in this notice shall receive the comprehensive lists of spares/equipment, further information on conditions of sale and subsequently receive an invitation to tender for part or all of these spares and equipment. For ease of administration, the aforementioned spares and equipment have been categorised as follows;

## **SCOPE OF THE TRANSACTION**

The spare parts and equipment to be sold are located at NLNG’s Plant Site in Bonny Island. All successful bidders shall be required to make payments for the goods of their bidding, to NLNG’s nominated bank account within 72 (seventy-two) hours from the announcement of the results. Upon confirmation of payment receipts by NLNG, winners shall immediately take

possession and evacuate their materials from the company premises within 5 (five) working days from the date of payment receipt.

NLNG may, depending on exigencies, be able to provide some limited logistical support for these transactions, including transport for personnel between NLNG Jetty in Port Harcourt and Bonny Island, and loading of materials onto winners' trucks to be positioned at the NLNG warehouse in Bonny Island.
