INVITATION FOR EXPRESSION OF INTEREST FOR THE COMPREHENSIVE MANAGEMENT AND OPERATIONS OF NEW ZOO ROAD PEDIATRIC AND GIGINYU SPECIALIST HOSPITALS

Kano State Government is desirous of improving the quality of health care services delivery in the state and in order to ensure efficiency and sustainability in operations the Ministry has opted to outsource the management of the following hospitals through “Public-Private-Partnership”:

LOT I – GIGINYU SPECIALIST HOSPITAL

LOT II – NEW ZOO ROAD PEDIATRIC HOSPITAL

(1.) Accordingly, Kano State Ministry of Health hereby request for Expression of Interest for the MANAGEMENT AND OPERATIONS of the hospitals from firms with requisite competence, technical and financial capacity and verifiable track record of managing and operating hospitals of similar capacity.

(2.) The successful firm(s) shall be responsible for the day-to-day operations of the hospitals including an integrated facility management, human resources management, equipment management as well as making any necessary investments to improve on the hospitals’ scope of health care services delivery in line with global best practices.

(3.) REQUIREMENTS FOR PRE-QUALIFICATION:

Expression of Interests (EOIs) from hospital management specialists/firms must clearly indicate the following:

- (i.) Full name, address and evidence of registration with CAC
- (ii.) Profile of company, including copies of all registration documents
- (iii.) Evidence of partnership in case of a consortium

- (iv.) Evidence of track record of executing similar services
- (v.) Evidence of Tax Clearance for 2013, 2014 and 2015 from the Federal Inland Revenue Services (FIRS) from any of the members of the consortium
- (vi.) Submission of Audited Accounts for 2013, 2014 and 2015
- (vii.) Evidence of Managerial, Professional and Technical Qualifications of Key Personnel of the firm or consortium
- (viii.) Evidence of Financial capacity and Bank guarantee from a reputable bank
- (ix.) VAT registration and evidence of past VAT remittances
- (x.) Tax Identification Number (TIN)
- (xi.) Evidence of settlement of PAYE and other withholding taxes due to the State
- (xii.) Evidence of Registration with Kano State Works Registration Board
- (xiii.) Evidence of Registration with Kano State Due Process Bureau
