- (i) Evidence of experience as a prime contractor on at least one project of similar nature and complexity within the last five years, stating client cost with completion certificates and photographs attached;
- (ii) Have a project manager of between 7-11 years experiences of equivalent nature and volume;
- (iii) Organizational structure with names of key personnel involved in project implementation stating qualifications and professional registration where applicable (enclose photocopies of professional certificates);
- (iv) Evidence of registration with CAC;
- (v) Evidence of Tax Clearance certificate for the last three years;

(vi) Annual Turnover and audited statement of account of the company for the last three years (2014-2016);

(vii) VAT registration and evidence of past VAT remittances;

(viii) Tax Identification Number (TIN);

(ix) Evidence of settlement of PAYE and other withholding taxes due to the State;

(x) Evidence of Registration with Kano State Due Process Bureau;
