INVITATION FOR EXPRESSION OF INTEREST FOR THE PROCUREMENT OF SULPHADOXIN AND PYRIMETHAMINE (SP) FANSIDER TABLES.

The Kano State Government in its desire to improve the quality healthcare delivery services in the State, the State Ministry of Health is hereby inviting prospective companies to express their interest in the Procurement of Sulphadoxin and Pyrimethamine (SP)/Fansider tables.

(2) SUBMISSION OF PRE-QUALIFICATION DOCUMENTS:

Interested companies/suppliers should submit the following pre-qualified documents to the Office of the DPR&S/Secretary SMTB (Ministry of Health, H/Quarters – Post Office Road, Kano) on or before **FRIDAY 31 JANUARY, 2020 not later than 12:00 noon.**

(3) THE REQUIREMENTS FOR PRE- QUALIFICATION ARE:

- (i) Evidence of experience as a prime contractor on at least one contract of similar nature and complexity within the last five years with certificate;
- (ii) Have a project manager of between 5-7 years experiences of equivalent nature and volume;
- (iii) Organizational structure with names of key personnel involved in contract execution stating qualifications and professional registration where applicable (enclose photocopies of professional certificates);
- (iv) Evidence of registration with CAC;
- (v) Evidence of Tax Clearance Certificate for the last three years;
- (vi) Annual Turnover and Audited statement of account of the company for the last three years (2016 – 2018);
- (vii) VAT registration and evidence of Past VAT remittances.
- (viii) Tax Identification Number (TIN);
- (ix) Evidence of settlement of PAYE and other withholding taxes due to the State;
- (x) Evidence of Registration with Kano State due Process Bureau/WRC;

(4) IMPORTANT NOTICE:

- (i) Late submission of pre-qualification documents will not be entertained
- (ii) Only companies/contractors that are adjudged successful in the pre-qualification screening exercise shall be invited to collect tender documents upon payment of non-

refundable fee of FIFTY THOUSAND NAIRA only (N50, 000.00) payable to the Account Section of the Ministry.
