(iv) That the Company does not at the time of this bid have any existing loan or financial liability with a bank or other financial institutions or third party that is classified as doubtful, non-performing, bad or whose repayment portion has been outstanding for the last three (3) months.

(h) Comprehensive Company Profile indicating technical (Architect, Structural, Mechanical, Electrical Engineers, Builders and Quantity Surveyors) and administrative staff strength, CVs stating phone numbers, academic and professional qualifications including photocopies of certificates respectively.
