#### (2.0) SCOPE OF THE WORKS

The scope of the works comprises all items outlined in the Bills of Quantities.

#### (3.0) PRE-QUALIFICATION CRITERIA

Interested corporate and/or individual firms should submit the following:

- (i) Certificate of registration with the Corporate Affairs Commission (for corporate entities)
- (ii) Evidence of Registration with The Kaduna State Public Procurement Authority
- (iii) Evidence of current registration of Business premises with the Kaduna State Ministry of Commerce and Industry,
- (iv) Company Audited Account for 2015,2016 and 2017.
- (v) Evidence of current Tax Clearance Certificates for 2015, 2016 and 2017.

- (vi) Evidence of VAT registration
- (vii) Evidence of similar jobs executed/ completed (attach copies of award letters, interim payment certificates/practical completion/certificate of making good defects)
- (viii) Evidence of technical key personnel in your employment (provide their qualifications and professional registration with appropriate professional bodies)
- (ix) Evidence of equipment and technology available for the works with evidence of ownership or hire.
- (x) Verifiable evidence of financial capability.
- (xi) Any other information that would be relevant.

The documents shall be arranged in this order, paginated and signed on each page by an authorized representative of the company.

#### **(4.0) COLLECTION OF BIDDING DOCUMENTS**

Interested companies/firms may purchase Bidding Documents at the cost of N25,000.00 (Twenty Five Thousand Naira Only), payable to Kaduna State Government. Payment tellers can be obtained at;

One Original and four copies are to be submitted in separate sealed envelopes clearly marked “Technical Bid” and “Financial Bid” and both placed in a third outer envelope. A copy of the Technical and Financial bid shall both be placed in a sealed fourth envelope and indicated at the top right side in addition to other information – “control copy” which shall be dropped in the Tender Control Box (TCB) All the four envelopes must bear the Company name and contact number at the reverse sides while the “Project Description’ and Lot No. clearly marked at the top left hand corner of the envelopes and addressed:
