**INVITATION FOR PRE-QUALIFICATION/ EXPRESSION OF INTEREST (EOI) FOR 2018  
CAPITAL PROJECTS FEDERAL MEDICAL CENTRE, GUSAU**

**(1.0) INTRODUCTION**

Pursuant to the implementation of its 2018 Capital Budget, the Federal Medical Centre, Gusau intends to execute some Capital Projects as provided for in 2018 Appropriation Act, in compliance with the provisions of the Public Procurement Act 2007. The Centre, therefore, invites interested and competent Contractors/ Suppliers and Consultants to submit Prequalification/ Expression of Interest (Eoi) documents for the execution of the Projects/Services as listed and described below:

**(2.0) SCOPE OF WORK**

The Projects which are for Supply of medical Equipment, Generating sets and Provision of Free Outreach Services are listed under categories A and B. Bidders are, therefore, requested to submit their respective Technical/Eoi documents for the category of interest.

**CATEGORY A**

Lot 1: Supply and Installation of CT Scanning Machine and Accessories.

Lot 2: Purchase of Medical Equipment.

Lot 3: Supply and Installations of Generating Sets.

**CATEGORY B**

Lot 4: Provision of Medical Outreach to Kaura Namoda/Birnin Magaji.

Lot 5: Provision of Medical Outreach in 4no. Local Government Areas in Zamfara State.

### **(3.0) PREQUALIFICATION REQUIREMENT**

- (i) Company Profile with curriculum Vitae of key officers including photocopies of relevant professionals/technical qualifications.
- (ii) Evidence of successful completion of similar work with copies of letters of Award and Certificate of Completion.
- (iii) Evidence of VAT Registration with TIN No. and past remittance for the last 3 years.
- (iv) Evidence of Financial capability in favour of Bidder from a reputable Bank addressed to the Medical Director to execute the Project.
- (v) Evidence of Certificate of Incorporation with the Corporate Affairs Commission (CAC) including Form CAC2 and CAC7;
- (vi) Evidence of Company Income's Tax Clearance Certificate for the last three (3) years valid till 31 December, 2018;
- (vii) Evidence of current Pension Compliance Certificate valid till 31 December, 2018;
- (viii) Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31 December, 2018;
- (ix) Evidence of current Nigerian Social Insurance Trust Fund (NSITF) Compliance Certificate Valid till 31 December, 2018.
- (x) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on January 1, 2019 or valid Certificate issued by BPP.
- (xi) A sworn affidavit disclosing whether or not any Officer of the relevant Committees of the Federal Medical Centre, Gusau or the Bureau of Public Procurement is a former or present Director, Shareholder or has any pecuniary interest in the Bidder and to confirm that all information presented in its bid are true and correct in all particulars;
- (xii) Company's Audited Account for the last three (3) years-2015, 2016 and 2017;
- (xiii) Evidence of Financial capability to execute the Project by submission of Reference Letter from a reputable commercial Bank indicating willingness to provide credit facility for the execution of the Project when needed;

(xvi) Company Profile with the Curriculum Vitae of key Staff to be deployed for the Project, including copies of their Academic/ Professional qualifications; including photocopies of relevant professionals/ technical qualifications.

(xvii) Verifiable documentary evidence of at least three (3) similar jobs executed in the last five (5) years including Letters of Awards, Valuation Certificates, Job Completion Certificates and Photographs of the Projects;

(xviii) All documents for submissions must be transmitted with a Covering/Forwarding Letter under the Company/ Firm's Letter Head bearing among others, the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone Number (preferably GSM Number) and e-mail Address. The Letter Head Paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorized Officer of the Firm.

**NB:**

(a) All submissions (comprising "Original" and "Copy") should be typed or written in indelible "Blue Coloured" Ink in accordance with ITT 31.2.

(b) The above listed requirements shall form part of the bid evaluation criteria and non-compliance will result in the disqualification of the Bidder's Technical/EoI document.

(c) Orderly presentations and arrangement scores marks.
