- (v) Evidence of compliance with the Industrial Training Fund (ITF) Amendment Act 2011 by inclusion of ITF Compliance Certificate **valid till 31 December, 2018.**
- (vi) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate **valid till 31 December, 2018.**

(vii) Evidence of registration on the Bureau of Public Procurement (BPP) Database of Contractors, Consultants and Service Provider by inclusion of Interim Registration Report (IRR).

(viii) Detailed company Profile to include Memorandum and Article of Association.

(ix) Evidence of financial capability to execute the project including Reference Letter from a reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed.

(x) Current Sworn Affidavit that:

(a) The Company is not in receivership, insolvent or bankrupt

(b) None of the Directors of the company has been convicted in any Court for any criminal offence including fraud and financial impropriety

(c) No Officer of National Hospital Abuja or the Bureau of Public Procurement is a former or present Director, Shareholder or has any pecuniary interest in the Company

(xi) All documents for submission must be transmitted with a Covering/Forwarding letter under the Company/Firm's Letter Head Paper bearing amongst others, the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone Number (preferably GSM No.), and e-mail address. The Letterhead Paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorised officer of the firm.

(ii) List of Equipment and Technology Capacity

(iv) List of Key Personnel with Curriculum Vitae to be deployed for the project including copies of Academic/Professional qualifications (e.g COREN, QSRBN, ARCON, CORBON, ICAN ANAN, etc).
