INVITATION FOR PREQUALIFICATION AND TENDER FOR THE EXECUTION OF 2018 CAPITAL PROJECTS NATIONAL OBSTETRIC FISTULA CENTRE ABAKALIKI EBONYI STATE

The National Obstetric Fistula Centre, Abakaliki Ebonyi State proposes to undertake the procurement of various goods under the 2018 Capital Budget in line with the Public Procurement Act 2007, the Hospital Invites Interested, competent experienced and reputable suppliers to submit documents for pre-qualification to tender for some projects and to tender directly for the execution of other projects as below.

(1) PROJECTS FOR PRE-QUALIFICATION AND TENDERING

(2) ELIGIBILITY REQUIREMENTS

Interested suppliers are required to submit the following documents for pre- qualification and direct tendering:

- (i) Certificate of Incorporation from Corporate Affairs Commission including Forms CAC2 & 7;
- (ii) Pension Compliance Certificate valid till 31st December, 2018;
- (iii) Current Tax Clearance Certificate for the last three years (2015, 2016, 2017) with minimum average turnover of N200 million. (average turnover of N200 minion applies to lot 1 -3 only);
- (iv) Industrial Training Fund (ITF) Compliance Certificate 31st December, 2018;
- (v) Nigeria Social Insurance Trust Fund Compliance Certificate (2018);
- (vi) Interim Registration Report ORR) expiring on 1/1/2019 or valid Certificate issued by Bureau of Public Procurement (BPP);
- (vii) A sworn affidavit;
- That none of the Directors of the Company has been convicted of any criminal offence;
- Sworn Affidavit disclosing whether or not any officer of the relevant committees of the National Obstetric Fistula Centre Abakaliki Ebonyi State or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;
 - (viii) Manufacturer's authorization from the approved manufacturers fisted in the procurement policy of medical equipment;
 - (ix) Company Audited Accounts for the last three years (2015, 2016 & 2017);
 - (x) Company profile containing list of experienced biometric engineers with

CVs attached and evidence of experience in installation or maintenance of similar equipment/copies of Academic/Professional Certificates.

- (xi) Completion Certificates of at least three (3) similar jobs successfully executed within the last five (5) years.
- (xii) Reference letter from a reputable commercial bank committing to fund the project if and when a warded.

(3) COLLECTION AND SUBMISSION OF TENDER DOCUMENTS

- (i) Tender Documents are obtainable from the Office of the Secretary Tenders Board Admin Block Upstairs Room 3.09 on presentation of a copy and original receipt of non- refundable Tender fee of N10,000 for Lots 4 to 16 paid into National Obstetric Fistula Centre Abakaliki (Remita Account) for each lot accordingly. Note that Lots 1 3 are for pre-qualification at this stage, only pre-qualified bidders will be invited at a later date for collection of Tender documents;
- (ii) Three copies of all pre-qualification documents (Lots 1- 3) must be submitted in one sealed tamper proof envelope.
- (iii) Completed Technical and Financial proposals (three sets of hard copy and 1 soft copy) for Lots 4-16 shall be submitted in two different sealed tamper proof envelopes and labeled 'Technical Bid" and "Financial Bid" respectively, and both placed in a third envelope. All the 3 nos. envelopes should bear the "Project Name" and Lot No. at the Top Right Hand Corner of the Envelope and addressed to:

(iv) All documents should be deposited in the appropriate tender box at the Admin Complex of National Obstetric Fistula Centre Abakaliki, Labeled pre-qualification or direct tendering whichever is applicable.

(4) CLOSING DATE AND TIME FOR SUBMISSION OF DOCUMENTS

Closing date/time for submissions of pre-qualification documents shall be 12:00 noon on **Monday, 3, September, 2018** and 12:00 noon on **Monday, 17, September, 2018** for direct tendering. Late submissions shall not be entertained.

(5) OPENING OF BID DOCUMENTS:

Technical Bids shall be opened in public Immediately following the deadlines stipulated I in paragraph 4 above at the Admin Complex of National Obstetric Fistula Centre, 86, Abakaliki-Enugu Expressway, Abakaliki, Ebonyi State.
