- (g) Evidence of current Registration with Nigerian Security and Civil Defence Corps (NSCDC) **2017**, for Provision of Security Services- Lot 17
- (h) Evidence of Registration with NAICOM for Provision of Insurance Cover-Lot 18
- (i) Company's Audited Accounts for the last three (3) years (2014, 2015 & 2016 respectively), showing annual turnover
- (j) Evidence of Financial Capability and Banking Support (Bank Reference from a reputable bank)
- (k) Verifiable evidence of similar jobs successfully executed or being executed by the firm (indicating contact addresses of clients, 3 or more Letters of Award and Job Completion Certificates (JCC) corresponding with such letters of award in the last five (5) years (2012 to 2016).
- (I) Company Profile and Technical qualifications of key professional staff with evidence of current registration with the relevant professional Bodies.
