- (ix) Evidence of registration on the National Database of contractors by inclusion of current interim registration receipt issued by the Bureau of Public Procurement (BPP)
- (x) Bank reference indicating financial capability of the contractor. Company profile with CVs of staff which should Include both Academic and professional qualifications.
- (xi) Verified and documentary evidence of at least three (3) similar jobs executed to include award letters and certificate of completion.

NB: Any other relevant documents that can facilitate pre-qualification will be an added advantage.

(4.0) SUBMISSION OF EOI DOCUMENTS

Prospective contractors are to submit bid for each Lot desired, separately packaged in sealed envelopes and clearly marked EOI and addressed to the Provost, FCT College of Education, Zuba, Lokoja-Kaduna Expressway. The submission should clearly indicate the name of the project and the Lot number. The reverse side of each sealed envelope should bear the name and address of the bidder/contractor.
