(2) ELIGIBILITY REQUIREMENTS

To qualify for the above, contractors with proven capability are to submit notice of intent to pre-qualify in the tender exercise which should be accompanied with the following documents/requirements:

- (i) Company registration certificate/incorporation with the Corporate Affairs Commission;
- (ii) Valid Tax clearance certificate covering at least the last three years;
- (iii) Evidence of Compliance with Pension Fund – PENCUM
- (iv) Evidence of Compliance with ITF contribution;
- (v) Evidence of Compliance with National Social Industrial Trust Fund (NSITF)
- (vi) Evidence of Interim Registration Report (IRR) from the Bureau of Public Procurement (BPP) Federal Contractors, Consultants and Suppliers Database;
- (vii) Court Sworn Affidavit that all information are true and correct and that none of the Company Directors have been convicted of any crime relating to fraud and also that none of the Directors is a staff of the College of Education, Katsina-Ala or Bureau of Public Procurement;
- (viii) Company profile and technical qualification of Key Personnel with registration with relevant professional bodies;
- (ix) Verifiable evidence of financial capability and bank support from a reputable Bank;

- (x) Verifiable list of projects executed;
 - (xi) Verifiable evidence of construction equipment with proof of ownership or lease agreement;
 - (xii) Evidence of payment of VAT for the last three years.
 - (xiii) Company's audited financial reports for the last three years;
 - (xiv) Verifiable evidence of payment of a non-refundable tender fee of N10,000.00 to be paid to the College Bursary Department.
- (3) Prospective bidders are requested to obtain the Tender Documents upon the payment of the proscribed fee of N10,000.00 payable to the Bursary Department, College of Education, Katsina-Ala.

(4) SUBMISSION:

- (i) 6 copies each of the Technical and completed Financial bids (Two sets of hard copies; i.e. Technical and Financial bids) shall be submitted in 2 separate sealed envelopes marked "Technical Bid" and "Financial Bid". - (ii) The documents should be deposited in the Tenders Box at the Provost's Office of the College to reach this office not later than **Wednesday 12 May, 2021 at 4.00pm.**
- (iii) All the bid documents submitted should be properly paginated with table of content clearly drawn.

All submitted tenders shall be opened on **Thursday, 13 May, 2021** in the College School of Science Staff Office Block Conference Room by 10am. All bidders, NGOs are invited to witness the public opening exercise.
