(b) Evidence of Tax Clearance Certificate for the Last three (3) years and must have a Minimum Average Turnover of ₦100million especially for those bidding for Construction Projects (Lots 1 & 2);

(c) 3years Audited accounts (2015, 2016 and 2017) duly stamped by a reputable audit firm.

(d) Current PENCOM Compliance Certificate expiring by December, 2018;

(e) Current ITF Compliance Certificate expiring by December, 2018;

(f) Current NSITF Compliance Certificate expiring by December, 2018;

(g) Registration on the National Database of Contractors, Consultants and service providers by inclusion of Interim Registration Report (IRR) issued by BPP expiring by January, 2019.

(h) Evidence of Letter of Authorization from the Original Manufacturer in accordance with Approved Policy for Procurement of Health and Medical Equipment/list of Manufacturers and Equipment of Nigeria must be provided for those bidding for Lots 3-6;

(i) Company profile which includes:

Name of current Directors registered with CAC

List of Affiliated companies overseas with dealings on Tools and Equipment.

List of similar project successfully executed on the subject matter of this procurement for the immediate past three years.

(j) Sworn affidavit indicating that:

None of the directors of the company has been convicted in any court of law for criminal offences involving financial impropriety.

No officer of the Federal Medical Centre Katsina is a former or present Director, shareholder or has any pecuniary interest in the company.

The company is not in receivership, insolvency or bankruptcy.

(k) Any other information that will further enhance the chances of short listing the company.
