- (5) Evidence of VAT Registration Certificate.
- (6) Company profile including names, qualifications and experience of Company staff with copies of credentials attached.
- (7) Evidence of financial capability to handle work from a reputable Bank.
- (8) Verifiable list of similar works successfully completed with names of clients and evidence of award/evidence of partial completion.
- (9) Evidence of registration with the appropriate Federal Works Registration Board.
- (10) Evidence of Compliance with industrial Training Fund (ITF) Act CAP 19. LFN2004.
- (11) Those applying for External Audit must be registered with Federal Auditor-General's Office
