The Federal Government of Nigeria has provided funds in the 2017 Appropriation for Federal Government Girls College, Bauchi through Federal Ministry of Education (FME), is desirous to utilize the fund to procure works in compliance with the Public Procurement Act, 2007. The School is inviting interested reputable and qualified Contractors with relevant experiences and good track records necessary for the execution of these projects:

**(2.1) SCOPE OF WORK:**

**(2.2) TENDER REQUIREMENTS**

**Interested and competent Contractors wishing to carry out the above job are required to submit the following documents which will be subjected to verification by the School:**

- (a) Evidence of registration with Corporate Affairs Commission (CAC);
- (b) Evidence of Current Tax Clearance Certificate (FIRS) for the last three (3) years (2014, 2015 and 2016) ending on 31st December, 2017 with TIN Number.
- (c) Names of Bankers with references;
- (d) Evidence of Financial Capability to execute the projects;
- (e) Company profile with CVs of key officers including photocopies of relevant professional/technical qualifications;

- (f) Evidence of registration with relevant professional bodies such as ARCON, COREN, CORBON. etc, (Works Component) only;
- (g) List of verifiable of Construction Equipment indicating ownership or lease agreement.
- (h) Verifiable evidence of successful completion of similar works within the past three (3) years with completion certificates;
- (i) Evidence of issuance of Compliance Certificate to all Organizations by PENCOM in line with Pension Reform Act 2004 (as amended);
- (j) Evidence of compliance certificate with the amended industrial training fund act, 2011;
- (k) Evidence of compliance certificate with relevant provision of the NSITF Act;
- (l) Submission of an interim Registration Report (IRR) as evidence of registration on the National Database of Contractors, issued by Bureau of Public Procurement.
- (m) A sworn affidavit disclosing whether or not any officer of Federal Government Girls College, Bauchi, FME or BPP is a former or present Director, shareholder or has any pecuniary interest in the bidder and confirm that all information presented in its bid are true and correct in all particular.

**(2.3) N.B:** The above listed requirement shall form part of the bids evaluation criteria and non-compliance with any of the stated conditions shall result in automatic disqualification of the bidder.

Interested eligible bidders may obtain further information from School's Tenders Board and inspect the Bidding Documents between 9:00am till 3:30pm (Mondays-Fridays) except public holidays. The address is:

A complete set of bidding documents shall be collected by interested bidders from the address in paragraph 2.3 above on the submission of written application for only one (1) lot accompanied by a non-refundable fee of Twenty Thousand Naira (N20,000.00) per lot in certified bank draft payable to Federal Government Girls College, Bauchi, with TSA Remitta Account. Contractors are not permitted to bid for more than one lot.

## **(2.5) SUBMISSION OF TENDER DOCUMENTS**

Completed Technical and Financial bids (two sets of hard copies) shall be submitted in 2 separate sealed envelopes. The two envelopes should be enclosed in a large envelope labelled "Technical & Financial Bids" with the Project name at the top right hand corner with company name behind and addressed:

## **(2.6) CLOSING AND OPENING DATE**

Submission of documents closes **12 noon on 3<sup>rd</sup> October, 2017**. Any bid received after the stated date and time shall not be considered. The submitted bids will be opened on the same day **3<sup>rd</sup> October, 2017** at the address below in the presence of the bidders' representatives, and interested members of the public. Bid opening venue shall be at: Office of the School Tenders Board, Federal Government Girls College, Bauchi.

## **(2.7) PLEASE NOTE THAT:**

(i) A post review of the Procurement Documentation may be carried out where Contractors, Suppliers and service Providers may be required to present the original copies of their CAC, PENCOM, TAX, ITF, NSITF Certificates and may thereafter refer any/all to the relevant Security Agencies for verification.
