### INVITATION FOR THE PRE-QUALIFICATION OF TENDER FOR CAPITAL PROJECTS UNDER 2018 APPROPRIATION AT ABUTH PERMANENT SITE SHIKA ZARIA AHMADU BELLO UNIVERSITY TEACHING HOSPITAL

#### (1) INTRODUCTION

The Ahmadu Bello University Teaching Hospital invites interested and reputable companies/contractors with requisite experience and competence to submit prequalification documents in respect of the 2018 capital projects execution in the Hospital.

#### (2) SCOPE OF WORKS

Lot 1	Construction and Equipping of Resuscitation Bay and Daycare Ward in Institute of Child Health (ICH) Banzazzau.
Lot 2	Construction and Equipping of Quality Control Laboratory for Pharmacy Department.
Lot 3	Procurement of Medical Equipment and Instruments to replace the old/outdated ones.
Lot 4	Rehabilitation and Expansion of Oxygen Gas Plant and Gas Piping to Ward Blocks "K" and "S"
Lot 5	Purchase of 1000kVA Generator Dedicated to Theatres, A&E, Dialysis, Radiology, ICU and Oncology.
Lot 6	Free Medical Outreach to Makarfi/Kudan Federal Constituency Kaduna State.
Lot 7	Rehabilitation of Schools: Schools of Nursing, Post Basic Nursing, Health Information Management, Biomedical Engineering

#### (3) PRE-QUALIFICATION CRITERIA:

Interested companies are required to submit the following documents and present original copies for sighting during the bid opening:

- (i) Verifiable Evidence of Incorporation and registration with Corporate Affairs Commission

(ii) Verifiable Evidence of Registration with BPP National Database of contractors by inclusion of current Interim Registration Report (IRR)

(iii) Tax Clearance Certificate verifiable from Federal Inland Revenue Services (FIRS) for the last 3years (2015, 2016 & 2017) expiring December 2018.

(iv) Company Audited Accountforthelast3years (2015, 2016 & 2017)

(v) Verifiable Evidence of VAT Registration with Tax Identification Number (TIN) and up-to-date evidence of remittance.

(vi) Verifiable Evidence of compliance with the Pension Reform Act 2014 by inclusion of current certificate of compliance from the National Pension Commission, where applicable.

(vii) Verifiable Evidence of compliance with the Industrial Training Fund (ITF) Amend Act 2011 by inclusion of current compliance letter from ITF.

(viii) Verifiable Evidence of compliance with the Nigeria Social Insurance Trust Fund (Employee Compensation Act 2010) by inclusion of current compliance Certificate from NSITF.

(ix) Manufacturer Authorisation in respect of Medical Equipment and Instruments.

(x) Every Submission must be accompanied with a sworn affidavit that all information and documents submitted are true and correct and that no officer of the procuring entity is a former or present director, shareholder or someone with any pecuniary interest in the bidding.

#### **(4) SELECTIVE CRITERIA:**

In addition to the above, bidders should also submit the following:

(i) Evidence of Financial capability supported with bank reference.

(ii) List of similar, verifiable and successfully executed projects/ongoing by the company with letters of award and completion certificates. Only letters of award and interim certificate of payment should be attached for projects that are ongoing.

(iii) Company profile including list of professional staff qualification which should include names, CV's and copies of certificate of each staff.

(iv) List of equipment owned or lease-hold by the company relevant for smooth execution of the project.
