## **INVITATION TO TENDER**

The Oyo State Universal Basic Education Board (OYO SUBEB) intends to apply the 2012 and 2013 FGN-UBEC/SUBEB Intervention Funds for the following facilities to be provided in the ECCDE, Primary and Junior Secondary School Sub-Sectors.

Applications are therefore invited from competent companies to bid for the various works.

## **(2) TENDER QUALIFICATION**

Each tender should be accompanied with the following:

- (a) Evidence of Company's Certificate of Registration with Corporate Affairs Commission (CAC).
- (b) Evidence of Company's Registration with Federal Inland Revenue Services. (FIRS).
- (c) Evidence of Registration with company's registration with Oyo State Bureau of Public Procurement
- (d) Evidence of verifiable previously executed jobs (Contractors with history of abandoned projects or poorly executed projects will not be considered).
- (e) Evidence of Registration of Business Premises with Oyo State Government.
- (f) Tax Clearance Certificate of at least 2 Directors (Limited liability Company) or the Proprietor/Partner (Enterprise) for the last three (3) years.
- (g) Evidence of payment of Tender Fee for each LOT.

**(A) LOT I – INFRASTRUCTURE**

*(i) Renovation of Classrooms, offices, library with oven baked coloured aluminium longspan roofing sheet in selected Public Primary Schools across the State.*

*(ii) Construction of ECD Pilot centre block with Terrazo and oven baked coloured aluminium longspan roofing sheet in selected Public Basic Schools across the State*

*(iii) Construction of 3-Classrooms block with Terrazo und oven baked coloured aluminium longspan roofing sheet in selected Public Basic Schools across the State*

*(iv) Construction of 4-Classrooms blocks with Terrace and oven baked coloured aluminium longspan roofing sheet in selected Public Junior Secondary Schools across the State.*

*(v) Construction of 6-Chssrooms blocks (storey building) with Terrazo and oven baked coloured aluminium longspan roofing sheet in selected Public Basic Schools across the State.*

*(vi) Construction of 20-Classrooms blocks (storey building} with Terrazo and oven baked coloured aluminium longspan roofing sheet in selected Public Basic Schools across the State.*

*(vii) Construction of 4-Compartment Toilet with oven baked coloured aluminium longspan roofing sheet in selected Public Basic Schools across the State.*

**(B) LOT II – INFRASTRUCTURE**

*Procurement and Supply of 2-Seater Pupils Desk and Benches, Teachers Table & 2 Chairs, Headteachers' Table &2 Chairs to selected Public Basic Schools across the State.*

**(3) TENDER MODALITIES.**

*(i) Tender documents and additional information may be collected from office of the Director, Planning, Research and Statistics Department.*

*(ii) Tenderers may tender for more than one LOT or LOTs separately.*

*(iii) Tendering shall be by open tendering*

*(iv) Tenderers should note that failure to include any of the required documents above renders the tender invalid for further consideration.*

**(4) BID SUBMISSION.**

All valid tenders should be submitted in 12" X 16" sealed envelope addressed to **the Executive Chairman, Oyo State Universal Basic Education Board, Agodi, Ibadan** with the LOT tendering for written on the right hand side of the envelope.

**(5) BID OPENING.**

Bid shall be opened publicly at the expiration of Tender period on **5th of December, 2017** at 12 Noon at the premises of Oyo State Universal Basic Education Board, Agodi, Ibadan. Bidders are advised to send representatives to the bidding exercise.
