- (x.) Audited Accounts of the Company for the last three years (2013, 2014 & 2015) fully signed and stamped by a professional accounting/audit firm and signed by the client.
- (xi.) List of verifiable building projects and renovations previously handled by your Company. You must clearly describe the listed building projects and renovations, stating Clients, Dates of Award, Project duration and dates of completion. (xii.) List of key personnel stating their role, designation qualification and years of experience (certificate of registration with professional bodies are to be attached) (xiii.) Evidence of current license/certificate and registration with relevant professional bodies e.g. CO REN, ARCON, QSRBN etc. by key technical staff. (xiv.)
