- (i) Evidence of compliance with Pension Fund PENCOM.
- (j) Evidence of compliance with ITF contribution.

(k) Attach a sworn affidavit that none of the Directors of the Company has ever been indicted by any Court of Law.

(I) Attach a sworn affidavit that none of the Directors of the Company was a former or current staff of CRUTECH and Bureau of Public Procurement.

(m) The Company must be registered with the Data Base of Bureau for Public Procurement.

Tenderers are to indicate the LOT Number at the left hand corner of the envelope and must be deposited in Tender Box at the Registry Department on or before Tuesday, 12th December, 2017 between 9.00am – 3.00pm daily. Late Tenders will be rejected.
