- (h) Company's Audited Accounts for the last 3 years (2015, 2016 and 2017).
- (i) Evidence of financial capability to execute the project including Reference letter from a reputable Commercial Bank indicating willingness to provide credit facility for the execution of the project when needed.
- (j) Company profile with the curriculum vitae of key staff to be deployed for the project including copies of their Academic and Professional Qualifications (such as COREN, QSRBN, ARCON, CORBON etc.).
- (k) Verifiable document evidence of at least three (3) similar jobs executed in the last five (5) years including letters of Award, Valuation Certificates and Photographs for ongoing projects, Job Completion Certificates.
- (I) List of Plants/Equipment with proof of ownership or lease (where applicable)
- (m) For Joint Venture/Partnership, Memorandum of understanding (MOU) should be provided (all eligibility requirements are compulsory for each partner)
