- (k) Verifiable document evidence of at least three (3) similar jobs executed in the last five (5) years including letters of Award, Valuation Certificates and Photographs for on-going projects, job Completion Certificates.

Prospective bidders are to submit bid for each of the Lot desired, two (2) hard copies each of the Technical and Financial bids with soft copy of financial bid (only in MS Excel format), packaged separately in sealed envelopes together in a bigger sealed envelope and addressed to the Principal Federal Government Girls College, Gwandu, Kebbi state and clearly marked with (the name of the Project and Lot number), Furthermore, the reverse of each sealed envelope should have the name and address of the bidder, and drop in the designated Tender Box in the Office of the Principal **not later than 12:00 noon on Monday 22 October, 2018**.

(6) The Technical Bids will be opened immediately after the deadline for submission by **12:00 Noon on Monday**, **22 October**, **2018** in Exams Hall, FGGC Gwandu, Kebbi state in the presence of bidders or their representatives, while the financial bids will be kept unopened.
