Accordingly, the college wishes to invite reputable contractors with relevant proven competence and experience to submit tenders for the execution of the following projects

(a) Evidence of Certificate of Incorporation with the Cooperate Affairs Commission CAC including Form CAC2 and CAC7 or FORM CAC 1.1.

(b) Evidence of Company Income's Tax Clearance Certificate for the last three (3) years valid till 31 December, 2018 with minimum of average turnover of (N20 Million).

- (c) Evidence of current Pension Compliance Certificate valid till 31 December, 2013.
- (d) Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31 December, 2018.
- (e) Evidence of current Nigerian Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31 December, 2018.
- (f) Evidence of Registration on the National Database of Federal Contractors. Consultants and Service Providers by submission of Interim Registration Report IRR expiring on 1 January, 2019 or valid certificate issued by BBP
- (g) Sworn Affidavit disclosing whether or not any officer of the relevant committees of the Federal Government Girls College, Langtang, Federal ministry of Education or the Bureau of Public Procurement is a former or present Director, Stakeholder or have any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars,
- (h) Company's Audited Accounts for the last 3 years (2015, 2016 and 2017).
- (i) Evidence of financial capability to execute the project including Reference letter from a reputable Commercial Bank indicating willingness to provide credit facility for the execution of the project when needed,
- (j) Company profile with the curriculum vitae of key staff to be deployed for the project including copies of their Academic and Professional Qualifications (such as COREN, QSRBN, ARCON, CORSON etc.).
- (k) Verifiable document evidence of at least three (3) similar jobs executed in the last five (5) years including letters of Award, Valuation Certificates and Photographs for ongoing projects, Job Completion Certificates'.
- (l) List of Plants/Equipment with proof of ownership or lease (where applicable)
- (m) For Joint Venture/Partnership, Memorandum of understanding (MOU) should be provided (all eligibility requirements are compulsory breach partner)
- (n) All documents for submission must be transmitted with a covering/forwarding letter under the Company's Firms Letter Headed paper bearing amongst others, the Registration Number (RC) as issued by Cooperate Affairs Commission (CAC) Contact Address. Telephone Number (Preferably GSM NO,) and e-mail address, the letter headed paper must bear the names and Nationalities of the Directors of the Company at the bottom of the page duly signed by the authorized officer the Company.

#### **(4) COLLECTION OF TENDER DOCUMENTS**

Interested Companies are to collect the Standard Documents (SBD) from the office of the Principal, Federal Government Girls College, Langtang on evidence of payment of a non-refundable fee of N10, 000 per Lot, paid into the Federal Government Girls College. Langtang's Remita Account in any Commercial Bank.

## **(5) SUBMISSION OF TENDER DOCUMENTS**

Prospective bidders are to submit bid for each of the Lot desired, two (2) hard copies each of the Technical and Financial bids with soft copy of financial bid (only in MS Excel format), packaged separately in sealed envelopes together in a bigger sealed envelope and addressed to the Principal "Federal Government Girls College, Langtang and clearly marked with (the name of the Project and Lot number). Furthermore, the reverse of each sealed envelope should have the name and address of the bidder, and drop in the designated Tender Box in the Office of the Principal not later than 12.00 noon on Monday, 3 September. 2018.

**(6)** The Technical Bids will be opened immediately after the deadline for submission **12.noon on Monday, 3 September, 2018** in Abuja Hall, FGGC Langtang in the presence of bidders or their representatives, while the financial bids will be kept unopened, Please, ensure that you sign the bid submission Register in the Office of the Principal as FGGC Langtang as the College will not be held liable for misplaced or wrongly submitted bids.
